These shares were withheld to satisfy the Reporting Person's tax withholding obligations. The Issuer will pay these taxes on behalf of the Reporting Person.

2. On the Grant Date, the Reporting Person was granted 2,723 RSUs which vest in four equal annual installments beginning on the first anniversary of the Grant Date.
