Of these shares, 405,000 are options exercisable within 60 days of December 31, 2013, 49,594,980 are shares held indirectly by 915 Investments, LP, in which the Reporting Person is the general partner, and the remainder of the shares are indirectly owned through various family trusts in which the reporting person is a trustee.
